Boarding Agreement

1. The Party filling out the attached Boarding/Day Care Intake Sheet ("Intake Sheet") agrees that he/she is legally responsible for the Pet named on the Intake Sheet (Owner). The Owner agrees that such legal responsibility shall apply regardless of the true nature of the relationship between the Owner and the Pet named in the Intake Sheet including but not limited to rescued pets and pets that for all other legal purposes outside of this agreement, may be owned by a third party.
2. Owner agrees to pay the rate for boarding or day care as indicated in the attached Intake Sheet.
3. Owner agrees to pay all costs and charges for special services requested, all veterinary costs, all damages that the pet may do to persons, property or other pets and any other costs related to the Pet.
4. Owner further agrees that the Pet shall not be removed from Blue Dog Ranch until all charges are paid to Blue Dog Ranch/PCDR by Owner. Any Pets that remain in the custody of Blue Dog Ranch/PCDR after the time listed on the Intake Sheet shall pay the same rate for any additional days or hours as listed in the Intake Sheet.
5. By executing this agreement below, Owner represents and warrants that the information on the Intake Sheet is true and correct. Owner agrees to indemnify Blue Dog Ranch for any liability caused by any inaccurate information listed on the Intake Sheet about the Pet, including but not limited to, costs associated with lawsuits and attorneys fees. Owner agrees that in admitting Pet to Blue Dog Ranch, that Blue Dog Ranch has relied on Owner's representations that Pet is in good health and has not harmed or shown aggressive or threatening behavior towards any person or another dog.
6. Blue Dog Ranch shall exercise reasonable care during the custody of Pet by Blue Dog Ranch. Owner agrees that Blue Dog Ranch and their staff and volunteers will not be liable for any problems that develop provided that reasonable care and precautions are followed, and Owner hereby agrees to release and hold them harmless from any liability of any kind whatsoever arising from Pet's stay at Blue Dog Ranch. In any other event, it is expressly agreed by Owner that Blue Dog Ranch's liability to Owner for Pet shall not exceed the lesser of the current chattel value of a pet of the same species or the sum of \$200. Owner disclaims any claim for a loss of Pet as a result of Pet contracting Parvo Virus or any other diseases while in the custody of Blue Dog Ranch/PCDR.
7. Owner specifically represents that Pet has not been exposed to Rabies, Parvo, or Distemper within a thirty (30) day period prior to boarding or daycare and that Pet is healthy and free of any and all contagious illnesses. Further, Owner represents that Pet is not aggressive with people or dogs and may be handled with other dogs. In the event of illness or injury to Pet, Blue Dog Ranch/PCDR shall have permission to treat Pet in its professional discretion.
8. All charges incurred by Owner shall be payable upon receipt of an invoice by Blue Dog Ranch/PCDR at address listed on intake Sheet or upon pick up of Pet. Blue Dog Ranch shall have, and is hereby granted, a lien on Pet for any and all unpaid charges resulting from Pet's stay at Blue Dog Ranch. Owner hereby agrees that in the event boarding or day care charges are not paid when due in accordance with this contract, Blue Dog Ranch may automatically exercise it's lien right fourteen days after Owner's failure to pay any amounts due and/or after Owner's failure to pick up Pet (California law provides that animals not picked up within 14 days of pick up date shall be abandoned). For the avoidance of doubt, fees shall continue to accrue to Owner after Blue Dog Ranch has enforced its lien rights herein. At Blue Dog Ranch's election, Blue Dog Ranch may but is not obligated to dispose of Pet for any and all unpaid charges or abandonment, at private or public sale in the sole discretion of Blue Dog Ranch, and Owner specifically waives all statutory or legal rights to the contrary.
9. In the event that Owner has not paid all fees and costs herein, Blue Dog Ranch shall have the right to exercise any legal remedy available including the filing of suit if a sale shall not secure a price adequate to pay such costs of board or other delinquent charges, plus costs of sale. Owner agrees that service to the address above by certified mail shall for all legal purposes constitute proper service unless Owner provides a different address in writing to Blue Dog Ranch/PCDR.
10. This contract contains the entire agreement between the parties and any changes must be in writing and executed by the parties. All terms and conditions of the contract shall be binding on the heirs, administrators. Personal representatives and assigns of the Owner and the Blue Dog Ranch/PCDR.
11. Any controversy or claim (except those that may be settled in small claims court) arising out of or relating to this contract, or the result of any claim of controversy involving the alleged negligence by any party to this contract, shall be settled by arbitration in accordance with rules of the American Arbitration Association, and judgment upon the award rendered by an arbitrator may be entered in any Court having jurisdiction thereof. The arbitrator shall, as part of his award, determine an award to the prevailing party of the cost of such arbitration and reasonable attorneys' fees of the prevailing party.
